## PROFESSIONAL ACTIVITY AND TRAINING

He is an expert, and has in-depth knowledge, in the following areas:

Contracts: consultation in negotiations and drafting of internal and international business contracts, judicial and extrajudicial assistance in the event of disputes. Corporate compliance privacy: assistance and consultation for companies regarding compliance, with particular reference to privacy, in accordance with the legislation introduced by EU Regulation no. 679/2016.
